We invite you to honor a member or members of your organization by nominating them for Carol Stream 2009 Citizen of the Year, Special Citizen of the Year or for the Judge's Recognition.

The Citizen of the Year Committee will honor all the nominees for Citizen and Special Citizen during a dinner at the Holiday Inn/Carol Stream on Saturday, February 6, 2010.

All nominees are recognized for the wonderful work they do for our community. Enclosed are nomination forms for your use. If you choose to nominate more than one person, the forms may be duplicated. Persons considered for Citizen of the Year must meet these requirements:

- Have been a resident of the Village for all of 2009
- Recognition must be due to volunteer service provided to the community of Carol Stream
- Service is for the calendar year of 2009
- Nominee may not have previously been awarded Citizen of the Year
- Nominee may not be the 2008 winner for Special Citizen of the Year

Persons considered for Special Citizen of the Year must meet these requirements:

- Have been a resident of the Village of Carol Stream for the past five years
- Have been committed to and provided continuous volunteer service to the community during that time
- Nominee may not be the 2008 winner for Citizen of the Year
- Nominee may not have been previously awarded Special Citizen of the Year
- If an individual has been nominated in both categories, he/she will be judged as Citizen of the Year only

Nomination forms are to be completed by the nominee. A SINGLE PAGE LETTER OF NOMINATION must accompany the nomination form. Preferably, the letter should be written (typed or use black pen since this letter is copied for the Judge's voting packet) by the individual making the nomination and confirmed by the President or Secretary of your organization, stating why the individual has been selected.

The Judge's Recognition is a separate and unique category. To be eligible for this recognition, the person must live outside the Village limits and have provided exemplary volunteer service on behalf of the community of Carol Stream. The organization suggesting the individual for the recognition should write a letter explaining why the individual is being honored.
